**MEMORANDUM OF AGREEMENT  
FOR  
REPORTING RESULTS OF REPRISAL INVESTIGATIONS**

1. This Memorandum of Agreement (MOA) is entered into by the Office of the Naval Inspector General (NAVINGEN), including the Office of the Deputy Naval Inspector General for Marine Corps Matters/Inspector General of the Marine Corps (DNIGMC/IGMC), and the Board for Correction of Naval Records (BCNR).
2. The purpose of this MOA is to facilitate the identification of petitions filed with the BCNR pursuant to 10 USC 1034, the Military Whistleblower Protection Act (the Act), and the recording of the results of BCNR action on those petitions.
3. This MOA becomes effective on March 28, 2012. Thereafter, either party may terminate the MOA upon 30 days' written notice to the other party.
4. On or before April 4, 2012, NAVINGEN and DNIGMC/IGMC will furnish BCNR lists of all hotline cases opened under the Act that were opened or closed between January 1, 2011 and March 28, 2012. The list will include the Inspector General (IG) case number, complainant's name, and, for closed cases, the DoDIG approved result (declined, substantiated, not substantiated).
5. BCNR will review the lists and if it determines a listed complainant has filed a petition with BCNR, it will inform the IG that listed the investigation, indicating whether the BCNR case remains open or has been closed and, for closed cases, whether the petition was granted or denied. As open cases are closed, BCNR will advise the cognizant IG of the results.
6. Commencing on April 2, 2012, NAVINGEN and DNIGMC/IGMC will show BCNR as a "blind copy to" on the acknowledgement letter sent the complainant upon opening a case under the Act and as a "copy to" on the case closing letter they send the complainant after DoDIG approves the final IG action in the case. NAVINGEN and DNIGMC/IGMC will provide BCNR copies of those letters within five business days of sending them to the complainant.
7. Should BCNR receive a petition from one of the complainants, it will notify NAVINGEN or DNIGMC/IGMC, as appropriate, so that the existence of the petition may be included in that IG's


hotline tracking system. When BCNR closes the case, it will send the appropriate IG a copy of the BCNR decision letter so the IG may include it in the hotline case file.
