- 1) If ICE officers are present in court;
 - a. If the alien is **In-custody** already (from DOC or PD arrest), the transfer of the detainee will take place in secure JMS lockup (secure-to-secure).
 - b. If the alien is appearing **at-large** (from street), ICE officers will, if the security situation allows, wait until the alien's hearing for which they are appearing is complete, then effect a court arrest under current procedures and escort the secured alien (ICE restraints/handcuffs) to JMS secure lockup. Officers will pull their GOV into the court secure sallyport to load in the arrestee.
- 2) If ICE officers are not present in court and a detainer has been lodged:
 - a. And CT JMS can honor the ICE detainer (meets one of the following 7 criteria: felony conviction; pending criminal charges in state where bond has not been posted; has an outstanding warrant in CT; gang member; TSC match; **has a final order of deport/removal**; unacceptable risk to public safety as determined by the LEO), CT JMS can hold until 5pm for ICE to assume custody.
 - b. If CT JMS cannot honor the ICE detainer (does not meet one of 7 criteria), CT JMS will give ICE office notification at earliest juncture of impending release to allow for enough time for ICE to coordinate transport.

This local SOP was developed in the interest of officer and public safety on both the part of ICE, court personnel and the general public. If you run into any situations contrary to this protocol please advise your supervisor. Please note that correctly noting a final order case on a detainer would go a long way in assisting the process of CT JMS honoring ICE detainers if that is the case status. I have viewed more than a handful of detainers where the box is incorrectly checked or there is not a checked box at all.

- 2) If ICE officers are not present in court and a detainer has been lodged:
 - a. And CT JMS can honor the ICE detainer (meets one of the following 7 criteria: felony conviction; pending criminal charges in state where bond has not been posted; has an outstanding warrant in CT; gang

member; TSC match; **has a final order of deport/removal**; unacceptable risk to public safety as determined by the LEO), CT JMS can hold until 5pm for ICE to assume custody.

- b. If CT JMS cannot honor the ICE detainer (does not meet one of 7 criteria), CT JMS will give ICE office notification at earliest juncture of impending release to allow for enough time for ICE to coordinate transport.

This local SOP was developed in the interest of officer and public safety on both the part of ICE, court personnel and the general public. If you run into any situations contrary to this protocol please advise your supervisor. Please note that correctly noting a final order case on a detainer would go a long way in assisting the process of CT JMS honoring ICE detainers if that is the case status. I have viewed more than a handful of detainers where the box is incorrectly checked or there is not a checked box at all.
