BRIEFING FOR HEARING, APRIL 9, 2020

On April 7, 2020, the Court ordered a hearing for April 9, 2020 at 2:00 PM to address the following:

The Court inquires whether given the number of cells and the common areas in the detention facility there is some number of detainees who might occupy the facility and yet be adequately spaced? Much like a nursing home or retirement facility. The views of physicians and public health professionals will be gratefully received.

ECF 55.

Shortly thereafter, Plaintiffs filed a Motion for Expedited Informal Discovery, ECF 57, seeking discovery into the questions raised by the Court. The Court granted that motion in part, ordering Defendant to produce certain information by 2:00 PM on April 8, 2020. ECF 60. Notwithstanding the Court's order, Defendant has not produced further information. Nor has Defendant filed any such information as of the filing time of this document, approximately one hour prior to the hearing on April 9, 2020.

Despite the lack of information from Defendant—the only party with ready access to the

information sought by the Court—Plaintiffs have endeavored to gather information that will be

helpful to addressing the Court's queries. Plaintiffs have gathered expert declarations from

several individuals, which are listed below and attached as exhibits to this filing.

Attached hereto as **Exhibit A** is the Supplemental Declaration of Dr. Matthew Gartland,

Attending Physician in the Division of General Internal Medicine at Brigham and Women's

Hospital in Boston, MA, and Pediatrics at Newton Wellesley Hospital, Newton, MA.

Attached hereto as Exhibit B is the Declaration of Dr. Frederick L. Altice, professor of

Medicine (Infectious Diseases), Epidemiology (Microbial Diseases), and Public Health, and a

clinician, clinical epidemiologist, and intervention and implementation researcher at Yale

University School of Medicine and School of Public Health.

Attached hereto as **Exhibit** C is the Declaration of Dr. Mary T. Bassett, physician,

epidemiologist and the director of the François-Xavier Bagnoud (FXB) Center for Health and

Human Rights and FXB Professor of the Practice of Health and Human Rights in the department

of Social and Behavioral Science at the Harvard T.H. Chan School of Public Health.
