W. MICHAEL REISMAN is Myres McDougal Professor Emeritus of Law at the Yale Law School where he has been on the Faculty since 1965. He has been a visiting professor in Tokyo, Hong Kong, Berlin, Basel, Paris and Geneva. He is a Fellow of the World Academy of Art and Science and a former member of its Executive Council, a former member of the Advisory Committee on International Law of the Department of State, and a member of the Board of The Foreign Policy Association. He has been elected to the *Institut de Droit International* and was the President of the Arbitration Tribunal of the Bank for International Settlements. He was President of the International Commission on Human Rights of the Organization of American States, Vice-President and Honorary Vice-President of the American Society of International Law, Editor-in-Chief of the American Journal of International Law and Vice-Chairman of the Policy Sciences Center, Inc.
