In this project, we will use quantitative secondary data and interviews with local and state officials (partnered with the New Haven Police Department and Project Longevity), to conduct an updated assessment of their programming.

The last [evaluation](#) of Project Longevity was completed in 2015, and co-authored by JC members [Andrew V. Papachristos](#) (Northwestern) and [Michael Sierra-Arévalo](#) (Rutgers), along with Yanick Charette (Laval University).
